Sisters in the Central Pacific Province (CP) work as educators in schools and parishes, and tutor immigrants and refugees. The sisters' ministries also include nursing homes, hospitals, prisons, spiritual direction, and opposing racism and poverty.



Today, SSNDCP ministers in 45 dioceses, 20 states, Ghana, Guam, Italy, Japan and Kenya. The sisters' positive impact is told in the lives of countless children, women and families throughout the world.

Leaving a Legacy gift

BEQUEST FROM YOUR WILL/LIVING TRUST: You may easily make a charitable gift of a specific dollar amount, a percentage of your estate/trust, a certain asset or make the School Sisters of Notre Dame Central Pacific Province, Inc. a “residual beneficiary.”

SECURITIES, STOCKS AND BONDS: The School Sisters of Notre Dame Central Pacific Province, Inc. welcomes gifts of publicly traded securities, stocks or bonds.



RETIREMENT PLANS: The School Sisters of Notre Dame Central Pacific Province, Inc. may be named as a beneficiary of your pension, 401k, IRA or other retirement plans.

LIFE INSURANCE: You may name the School Sisters of Notre Dame Central Pacific Province, Inc. as a full or partial beneficiary on life insurance policies you may carry.

GIFTS OF PROPERTY: A charitable contribution of property – a primary residence, vacation home, commercial real estate or parcel of land – is a gift that might have income and tax advantages. You may be able to gift your residence to the School Sisters of Notre Dame Central Pacific Province, Inc. while you maintain lifetime use of the property.
